- Participants must be an artificial tree no larger than 12 feet high and no smaller than 5 feet.
- The tree MUST have lights. Only led lights will be allowed for power purposes.
- All entries must provide one sign with the participant's name on it to be placed next to the tree.
- Trees must be decorated with the Christmas Parade theme of "Christmas in Toyland".
- Decoration Day will be on November 30th from 2:30 pm until 6:00 pm.
- The Monroeville / Monroe County Chamber of Commerce, the City of Monroeville, and the Monroe County Museum will not be help responsible for any damaged, missing trees and/or decorations.
